DISPOSITION ORDER (Amended December 10, 2022)

WHEREAS on the 17th of December 2015, the accused was found not criminally responsible on account of mental disorder on a charge of theft under \$5000, contrary to Section 334(B) of the Criminal Code, occurring September 1, 2015 in Kennetcook, Nova Scotia; a charge of theft of a motor vehicle, contrary to Section 333.1 of the Criminal Code, occurring September 9, 2015 in Kennetcook, Nova Scotia; a charge of mischief, contrary to Section 430(3) of the Criminal Code, occurring September 16, 2015, in Dartmouth, Nova Scotia; two charges of theft of a motor vehicle contrary to Section 331.1 of the Criminal Code, occurring September 19 through 21, 2015 in Upper Kennetcook, Nova Scotia; a charge of theft of a motor vehicle contrary to Section 333.1 of the Criminal Code; and a charge of failure to comply with a recognizance contrary to Section 145(3) of the Criminal Code, occurring October 1, 2015 in Upper Kennetcook, Nova Scotia;

AND WHEREAS the accused is currently residing in the community on a previously granted Conditional Discharge;

AND WHEREAS a hearing was held on the 6th day of April 2021 to make a Disposition Order pursuant to section 672.54 of the Criminal Code;

AND WHEREAS the East Coast Forensic Hospital is designated for the custody, treatment or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made;

IT IS ORDERED THAT the accused be conditionally discharged, on the following terms:

1. Keep the peace and be of good behaviour;
1. Maintain good mental health;
2. Adhere to the recommendations of the Community Mental Health Team;

3. Comply with follow-up by the Forensic Community Program;
4. Comply with conditions recommended by the Forensic Community Program;
5. Abstain from alcohol, cannabis and/or illicit drugs and comply with random urine drug screening;
6. Reside in the premises approved by the East Coast Forensic Hospital and abide by the rules and regulations of the residence;
7. Notify the Review Board and the East Coast Forensic Hospital of any change of address;
8. Appear before the Board when requested;
9. Remain within the Province of Nova Scotia; and
10. No contact with Nadia Dajani.

AND IT IS FURTHER ORDERED that if the accused is arrested pursuant to section 672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Program, Nova Scotia Health Authority, in Her Majesty's name, to execute the terms of this Order. The Board delegates to them the authority to increase or decrease the liberties of the accused pursuant to section 672.56(1).
