DISPOSITION ORDER

WHEREAS on the 16th day of September, 2016, the accused was found unfit to stand trial on a lengthy series of offences contrary to the Criminal Code which occurred between April of 2014 and April of 2016, namely: mischief, s. 430(4); causing a disturbance, s. 175; assault of a peace officer, s. 270; resisting a peace officer, s. 129; failure to comply with a condition, s. 145; causing a disturbance, s. 175; failure to comply with an undertaking, s. 145 (5 counts); failure to attend court, s. 145; mischief, s. 430; assault, s. 266; uttering threats, s. 264.1; causing a disturbance, s. 175; failure to comply with a condition, s. 145; assault, s. 266 (2 counts); assault causing bodily harm, s. 267; mischief, s. 430; failure to comply with a condition, s. 145; assault, s. 266; failure to comply with an undertaking, s. 145; failure to comply with a recognizance, s. 145; assault, s. 266 (2 counts); mischief, s. 430; assault with a weapon, s. 267; uttering threats, s. 264.1; failure to comply with a recognizance, s. 145; failure to comply with a recognizance, s. 145; failure to comply with a recognizance, s. 145 (2 counts);

AND WHEREAS the accused is presently detained in hospital;

AND WHEREAS a hearing was held at the East Coast Forensic Hospital on the 7th day of November, 2017, to make a Disposition Order pursuant to section 672.54 of the Criminal Code; AND WHEREAS the East Coast Forensic Hospital is designated for the custody, treatment or assessment of the accused in respect of whom an assessment order, disposition or placement decision is made;

IT IS ORDERED that the accused continue to be detained in hospital with a ceiling of privileges of L4, the Board finding her to be unfit to stand trial.

THIS IS THEREFORE TO COMMAND YOU, the Director, Mental Health Services, Capital District Health Authority, in Her Majesty's name, to execute the terms of this Order. The Board

delegates to him pursuant to section 672.56(1) the authority to direct that the restrictions on the liberties of the accused be increased or decreased within the limits set out in this disposition.
