

**IN THE MATTER OF the NOVA SCOTIA REVIEW BOARD**  
**AND IN THE MATTER OF the accused, SHAWN HOWARD TIMMONS**  
**AND IN THE MATTER OF a hearing held pursuant to section 672.81 (1) of the Criminal Code**

**DISPOSITION ORDER (Amended December 10, 2022)**

**WHEREAS** on the 28th day of October, 2016, the accused was found unfit to stand trial on account of mental disorder on a charge of assault, contrary to section 266 of the Criminal Code, unlawful confinement, contrary to section 279(2) of the Criminal Code, and overcoming resistance to commission of an offence, attempts to choke, suffocate or strangle another person, contrary to section 246(a) of the Criminal Code;

**AND WHEREAS** the accused is currently residing at the East Coast Forensic Hospital on a previously granted Conditional Discharge;

**AND WHEREAS** a hearing was held on the 1st day of March 2022 to make a Disposition Order pursuant to section 672.54 of the Criminal Code;

**AND WHEREAS** the East Coast Forensic Hospital is designated for the custody, treatment or assessment of the accused, in respect of whom an assessment order, disposition or placement decision is made;

**IT IS ORDERED THAT** the accused continue to be conditionally discharged, on the following terms:


1. Keep the peace and be of good behaviour;
1. Maintain good mental health;
2. Adhere to the recommendations of the Community Mental Health Team;
3. Comply with follow-up by the Forensic Community Program;
4. Comply with conditions recommended by the Forensic Community Program;

5. Abstain from alcohol, cannabis and/or illicit drugs and comply with random urine drug screening;
6. Reside in the premises approved by the East Coast Forensic Hospital and abide by the rules and regulations of the residence;
7. Notify the Review Board and the East Coast Forensic Hospital of any change of address;
8. Appear before the Board when requested;
9. Remain within the Province of Nova Scotia unless authorization in writing has been received from the Board.

**AND IT IS FURTHER ORDERED** that if the accused is arrested pursuant to section 672.91 of the Criminal Code for a breach or anticipated breach of the terms of this disposition, they may, under section 672.92(1)(b) of the Criminal Code, be delivered to the East Coast Forensic Hospital, 88 Gloria McCluskey Avenue, Dartmouth, Nova Scotia.

**The Board finds that the accused remains unfit to stand trial.**
