# Complaint of Unfair Labour Practice (*Trade Union Act,* Sections 53, 54, 55)

This form can be used to make a complaint of an unfair labour practice. Do not use this form if your complaint relates to the Duty of Fair Representation (use Form 22 instead).

By filing this complaint, the complainant claims that:

- The employer engaged in prohibited activities under section 53 of the Trade Union Act; and/or
- The union engaged in prohibited activities under section 54 of the *Trade Union Act*.

### Important to note:

- Do not modify this form.
- This form must be completed in its entirety and properly signed before the application will be processed. The authority to sign an application is dealt with in Section 5 of the <u>Trade Union Act</u>.
- Applications may be delivered by fax, email, personal service, or by registered mail or other similar mail services.
- If some of your complaint falls under section 54, you may be required to follow resolution procedures established by the union before bringing this complaint.
- If you wish to make a complaint related to section 35 (i.e., failure to bargain), such a complaint must be made to the Minister of Labour, Skills and Immigration.
- This form must be filed within 90 days of when the complainant knew, or ought to have known, of the action or circumstances that give rise to the complaint.
